**AUCTION SALE NOTICE**

Sealed Tenders as per the prescribed proforma (enclosed) are invited by the undersigned for disposal of Ambassador Diesel Car of Odisha State Commission for Women bearing Registration No. OR-02AR-6446, which was purchased on 25.01.2008 has been declared condemned vide this Office Order No. 15213 dt. 13.12.2021. The Offset price of the vehicle is fixed at Rs. 15,000/- (Rupees fifteen thousand) only. The above vehicle will be disposed off as and where basis.

2. The intending bidders are advised to inspect the vehicle parked in the Toshali Bhawan, Satyanagar, Bhubaneswar premises between 11.00 A.M to 3.00 PM. The tender should accompany earnest money deposit of Rs 1,000/- (Rupees one thousand) only in shape of Bank Draft in favour of Convenor Secretary, Odisha State Commission for Women payable at State Bank of India, Janapath Branch, Bhubaneswar which will be refunded/returned to the bidders whose tenders are not accepted except in case of the successful bidder.

3. The sealed tenders/bid super scribed "Auction Sale Bid for vehicle No. OR-02AR-6446" should reach the undersigned by 04.01.2022 within 3.00 P.M at the latest and tenders received shall be opened in the Office Chamber of Convenor Secretary, Odisha State Commission for Women at 4.00 P.M on the same date in presence of the tenders or their authorized representatives. If this day is declared later as a Government holiday, then the tenders will be received and opened on the next working day as per the scheduled time.

4. The highest tenderer, whose tender will be accepted, shall deposit immediately 25% of the offered amount as initial deposit. He shall deposit the balance amount within 07 (seven) days of the deposit of the initial amount. In case the tendered fails to make deposit of the total amount as per the tender within the stipulated time, the deposit including the earnest money shall be forfeited.

5. The successful bidder shall take permission and remove the vehicle from the Toshali Bhawan, Satyanagar, Bhubaneswar premises within 07(seven) days of deposit of the total bid amount. On failure to remove the vehicle within the aforesaid time, ground rent @ 1% of the tendered amount shall be charged for each day or part of the day till removal of the vehicle from the aforesaid site. If the ground rent so charged, exceeds the sale price deposit, then the tenderer shall cease to have any right on the vehicle & the amount deposited by him shall be adjusted towards ground rent.
